#### CANCELLATION POLICY

 $\sqrt{AII}$  cancellations must be made in writing or by telephone prior to arrival.

In case of flexible reservation conditions: The cancellation period without charge is 48 hours before the date of arrival: in this case we refund the prepayment.

To less than 48 hours, we keep the prepayment as cancellation compensation.

#### RESTAURANT
